3RD VPL BIENNALE

General terms

1. Registration / Approval

A maximum of 250 participants can join the event "VPL Biennale 2019".

The registration is binding upon submission of the registration data. An invoice will be sent to the specified e-mail address. Participation in the event is approved when the invoice has been paid and our confirmation of participation has been sent to your e-mail address. If the bill is not paid within 2 weeks after the second reminder, the registration will be automatically canceled. After the 15th March 2019 onwards the registration will be canceled 1 week after the second reminder.

The host of the VPL Biennale 2019 is entitled to refuse a registration, in particular if the VPL Biennale 2019 is already overbooked. Applications will be accepted on a first come first serve basis of payment, if necessary a waiting list is will be started. You will be informed accordingly. There is no claim to participation. A refusal does not have to be justified.

Registration is personal.

As part of the registration process, the organizer requests personal data that is stored and processed (see data protection notice point 6). Necessary details (mandatory fields) are marked as such, all other information is voluntary. Registration is only possible with complete filling of the mandatory fields.

2. Event fee

The event fee cannot be reduced if you do not want to participate fully in the event. Travel and accommodation expenses incurred are to be endured by you.

3. Cancellation of the participants

In case of cancellation (after payment of the registration fee), a 50 € handling fee will be charged. For withdrawals after 31 March 2019, the full registration fee will be due.

4. Photography and Filming

Photography and/or filming may take place during the event.

The photographs and films could be used by the organizer for promotional purposes and may be published on the organizer's website as well as social media (facebook, youtube etc.) and circulated to the press and other media organisations for publication, transmission or broadcast.

5. Release of the created works

Considering the participant has created any (written or oral) contributions protected by copyright in the course of the VPL Biennale 2019 he/she hereby grant to the organizer all and any non-exclusive, but transferable rights, without limitation as to content, time and geographical area, to use and exploit the contributions in whole or in part; this includes the right to abridge such contributions, prepare summaries thereof (especially in the form of abstracts), combine such contributions with other contributions and to publish and distribute the contributions. More specifically, the organizer itself or acting through third parties is entitled to reproduce, publish, distribute and make available for download and/or in e-book format in connection with e-books in any paper or book format through the publishing house of the organizer and/or third-party publishers on data media, on the Intranet of the organizer, and/or online on the web pages of the organizer or third parties (without any limitation as to the number of editions or press run).

These rights are granted simultaneously with this consent and shall continue to apply throughout the duration of the copyright protection.

The organizer shall quote the participant's name and point out his participation in connection with the VPL Biennale 2019 in all publications

6.4."Am I under an obligation to provide personal information?"

6.5."Who comes into possession of my personal information?"
